  - The Readington Township Environmental Commission collected their last 3 sample collections on Monday 10/30. She's analyzing the samples for E.coli/MST (human marker) at RC23P as a base line, then one at Windy Acres and one at Nelson St.
- Mario Seeds purchased for Community Day
  - Keep the seeds until next year for Community Day. No objections.
- Doug Exxon Dam removal
  - No update.
  - Will draft a letter requesting an update. To a vote to send a letter requesting an update. Rob moved the motion, Doug seconded. All in favor.
- Mario Hunterdon Env. Academy Rock Salt sampling
  - o How much rock salt Clinton Township used last year? Mario will reach out to Jay.
  - Last year we collected samples through salt watch. Four locations Rockaway Creek, Beaver Brook, South Branch, and Cramer's Creek. Last year we collected baselines.
- Doug Bamboo Ordinance
  - o Ordinance was requested by a citizen.
  - o There are over 4,000 species of bamboo. There are few that are native.
  - The invasives in this area are from Asia where the climate is similar to our area.
  - Chokes out the native plants.
  - Doug moved the motion to move forward with the ordinance. Mario seconded the motion. All in favor except for Robert. Suggested that we take Readington's Ordinance and have our attorney review it. Amy will present it to the Council at the meeting this coming Wednesday.
