AUTHORIZING THE PURCHASE OF ASPHALT WITH STAVOLA, STATE CONTRACT #18-FLEET-00637

AMENDING RESOLUTION #49-2022 AUTHORIZING THE PURCHASE OF GASOLINE AND DIESEL FUEL THROUGH THE MORRIS COUNTY CO-OP, CONTRACT #1 FOR MOTOR GASOLINE AND CONTRACT #12 FOR ULTRA LOW SULFUR DIESEL FUEL, INCREASING THE NTE TO \$155,000

WHEREAS, there is a need to amend resolution #49-2022 to purchase gasoline and diesel fuel to be used by the Department of Public Works, Police, Fire and other municipal departments; and

WHEREAS, the Township belongs to the Morris County Co-op and purchases gasoline and diesel fuel through this program for the year.

WHEREAS, the funds are available as evidenced by the Chief Finance Officer's Certification through account #01-201-31-460-261; and

1. Gasoline and diesel fuel shall be purchased through the MCCPC from Griffin Allied Trucking D/B/A Allied Oil, increasing the NTE amount to \$155,000.
