WHEREAS, the Township wishes to enter into a professional services agreement ("Agreement") with Consultant for the provision of professional legal services as described above; and

WHEREAS, the Township has a need to acquire these services without a "fair and open process" as defined by P.L. 2004, c.19, the "Local Unit Pay-to-Play Law"; and

WHEREAS, Consultant has completed and filed with the Township the required Campaign Contributions Affidavit pursuant to N.J.S.A. 19:44A-20.8 and Certification Regarding Political Contributions pursuant to N.J.S.A. 19:44A-20.26 (collectively, the "Pay-to-Play Forms"); and

WHEREAS, the Agreement shall be for an amount not to exceed \$6,000.00 and a term of one year retroactive to February 1, 2023, as more specifically described in the Agreement; and

WHEREAS, the Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-5(1)(a)(i), authorizes the Township to award this agreement as a professional services agreement, without public bidding; and

WHEREAS, there are sufficient available funds for this award, as set forth in the Certification of Available Funds completed by the Chief Financial Officer;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Clinton in Hunterdon County, New Jersey, as follows:

- 1. The Mayor and Clerk are hereby authorized and directed to execute a one-year Professional Services Agreement with Consultant to provide professional legal services to the Township by serving as a hearing officer in a disciplinary matter.
- 2. Consultant shall be compensated at the rate of \$185 per hour, in an amount not to exceed \$6,000.00. The term of the agreement shall be from February 1, 2023 to January 31, 2024.
- 3. The agreement is awarded without competitive bidding as a professional services agreement as authorized under N.J.S.A. 40A:11-5(1)(a)(i).
- 4. A copy of this resolution, the Pay-to-Play Forms and the Agreement shall be placed on file in the Office of the Clerk.
- 5. A notice of this action shall be published in the Township's official newspaper as required by law.
