Council President Strauss chaired the meeting in lieu of the Mayor.

Council President Strauss read the Public Notice at 7:03 pm.

COMMENTS FROM THE PUBLIC FOR ITEMS LISTED ON THE AGENDA ONLY (Note: The Mayor and Council will take public comment on the ordinance(s), if any, under Section G, during the Public Hearing portion).

Andrea Gordon, Clinton Township, asked questions and had concerns about the affordable housing units that are being built in the Township on Route 31. Ms. Gordon

also asked about the potential sale of the Transfer Station on Petticoat Lane. Members of the Council advised Ms. Gordon of the requirements by the State for the affordable housing statues. Administrator Close shared with Ms. Gordon if she has questions or concerns about the Transfer Station, to please contact the County with her concerns, and stated that all questions and comments about the Transfer Station should be submitted by September 25th to the Clerk of the Board of County Commissioners.

REPORTS FROM COUNCIL MEMBERS AND MAYOR

Councilman Glaser reported that the regular meeting for the Planning Board was canceled for July 10th and a special meeting is scheduled for July 24th to adopt the Annandale Village resolution. The Sewerage Authority has canceled both meetings for July and August but will host a special meeting on July 20th. The Finance Committee has nothing to report on, however Councilman Glaser mentioned that the State budget did not include the \$200 million Governor Murphy proposed to offset the impact of the increase in the State Health Plan, but it did include a \$75 million increase verse the prior year in the energy tax in the municipal allocation, which will result in an increase to the Township. The resident who is interested in the micro cannabis license in the Township is still interested in attending a work session with the Council within the next few months to discuss the suitability within the Township.

Councilman Kochanowski had nothing to report for this meeting.

Councilwoman Switlyk shared Environmental Commission correspondence that were brought to her attention over the last few weeks, the dam removal at Beaver Brook, and a resident's concern about the Transfer Station as well. A letter will be sent on behalf of the Commission to the County regarding the residents' concerns. There will not be a meeting in August for the Commission. The Green Fair was held this past weekend and the numbers weren't where they were expected to be but she believed that the weather played a factor and asked if the Green Team can join on the food truck festival in the fall in hopes of an increase of numbers. The vendors at the food truck festival this past weekend did a great job and are looking forward to the fall event. The committee would like to try to get a silver certification this year instead of bronze. Classes and preparations for the train station cleanup will help with the silver nomination. There was an electric fence set up near the beehives, which is solar powered, to protect them from wildlife. They are hoping to get two more beehives as well. The hunting orientation has been completed.

Councilman Kochanowski asked about decals being put on the DPW and Police vehicles in the Township to show the certifications that the Township has received. Administrator Close mentioned that it will be looked into and can be placed on the DPW vehicles if approved.

Council President Strauss did not have reports on the Board of Education or the Historical Society but reported on Public Safety and advised that reports have been emailed and shared from the Police Department and Fire Chief. The fire department facilities will receive work to keep the buildings manicured. The CERT team assisted with the 4th of

July parade in Lebanon. A correspondence came in from a resident asking if it would be possible to keep up on the maintenance of the landscaping at the Old Municipal building

Council President Strauss asked the Administrator if the Mayor had updates. There were no updates from the Mayor at this time.
