RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON AUTHORIZING THE HIRE OF RUTH MULLIGAN AS A TEMPORARY PART-TIME VIOLATIONS CLERK IN THE CLINTON TOWNSHIP MUNICIPAL COURT

WHEREAS, due to the resignation in the Clinton Township Court, there exists a need to hire a temporary part-time Violations Clerk for the Municipal Court; and

WHEREAS, Court Administrator Kim Marino recommends that the Governing Body reappoint Ruth Mulligan as the temporary part-time Violations Clerk, effective March 18, 2024; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Clinton as follows:

RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON ACKOWLEDGING THE SUPPORT OF DWI ENFORCEMENT SUPERBOWL WEEKEND SAFE PASSAGE EVENT FROM FEBRUARY 11, 2024, THROUGH FEBRUARY 12, 2024, IN THE TOWNSHIP OF CLINTON

WHEREAS approximately one-third of all fatal traffic crashes in the United States involve impaired drivers; and

WHEREAS impaired driving crashes killed 11,654 people in the United States in 2020; and

WHEREAS impaired driving crashes cost the United States almost \$44 Billion a year; and

WHEREAS, during the past five years New Jersey's roadways experienced 33,798 crashes and 662 fatalities involving impaired drivers; and

WHEREAS an enforcement crackdown is planned to combat impaired driving; and WHEREAS, the State of New Jersey, Division of Highway Traffic Safety, has asked law enforcement agencies throughout the state to participate in the Impaired Driving Enforcement; and

WHEREAS the project will involve increased impaired driving enforcement from February 11, 2024, through February 12, 2024; and

WHEREAS an increase in impaired driving enforcement and a reduction in impaired driving will save lives on our roadways;

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey as follows:

- The Township supports the DWI Enforcement Superbowl Weekend Safe
 Passage Event through Somerset County Prosecutors office from February 11,
 2024, through February 12, 2024, and pledges to increase awareness of the
 dangers of drinking and driving.

REPORTS FROM MAYOR AND COUNCIL MEMBERS

Councilman Glaser reported the Planning Board met on April 1st for normal administrative matters, with the two North Hunterdon Capital reviews being carried to a future meeting. The meeting scheduled for April 15th has been canceled but the Board of Adjustment will be holding a special meeting on that day. The next Planning Board meeting is scheduled for May 6th. The Highlands Council Regional Master Plan Committee will have a meeting on April 15th to discuss the adoption of the pending warehouse and land use capability zone map amendments, and discuss an affordable housing amendment to the Regional Master Plan Committee. The Sewerage Authority met on April 4th for routine matters. Next meeting is scheduled for May 9th at 8:30 am. The Public Hearing for the 2024 Township Budget is set for Wednesday April 24th at 7 pm.

Councilman Kochanowski shared that Community Day is on April 27th starting at 2 pm.

Council President Strauss shared that the Board of Education's final budget is scheduled for April 29th at 7 pm. The Historical Commission is completing a grant application for the Vought House and has been planning Community Day items. Reports from the Police, Fire, and EMS regarding updates from the Departments and earthquake have been shared.

William Close thanked everyone who was involved with the earthquake assessments and helping residents this past Friday. No major damage was reported, and Township personnel will continue to check the Township buildings and trails for the next few days following the earthquake and settling.

The Council thanked Mr. Close for his assistance on the earthquake matters.

BE IT FURTHER RESOLVED that the Township of Clinton also, upon the receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the Township of Clinton and the New Jersey Department of Community Affairs; and

BE IT FURTHER RESOLVED that the persons whose names, titles, and signatures appear below are authorized to sign the application, and that they or their successors in said titles are authorized to sign the agreement, and any other documents necessary in connection therewith:

RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON AUTHORIZING THE SUBMISSION OF A LETTER OF SUPPORT FOR S-2946 / A-4505, FOR NEW JERSEY'S MEDICAID REIMBURSEMENT RATE FOR EMERGENCY MEDICAL SERVICES (EMS) BASIC LIFE SUPPORT TRANSPORTATION

WHEREAS, New Jersey's Medicaid reimbursement rate for Emergency Medical Services (EMS) Basic Life Support transportation is \$58.00 per trip; and

WHEREAS, the rate is reported to be the lowest rate in comparison to neighboring states and is among the lowest nationwide; and

WHEREAS, the rate of \$58.00 per trip has been in existence since 1994, and is no longer sustainable for the EMS system; and

WHEREAS, the New Jersey EMS System is facing a critical staffing crisis, rising costs due to inflation, and the emergency medicine industry becoming more complex;

WHEREAS, the Mayor and Council of the Township of Clinton endorses bills S-2946/ A-4505 which increase the EMS Medicaid transportation rate to \$200.00 per trip, which better aligns with rates imposed by neighboring states;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey, as follows:

- The Mayor is hereby authorized to prepare and submit on behalf of the Township a letter of support for Senate Bill No. 1423 and send to the State of New Jersey, and local Senators and Assemblypersons.
- 2. This resolution shall take effect immediately.
