Clinton Township residents and Clinton Township employees can submit all required paperwork starting at 8AM on June 6th. Non-residents can submit all required paperwork starting at 8AM on June 13th.

- o Signed certificate of eligibility that no felony convictions or violations of local regulations pertaining to parks or hunting
- o Signed release authorizing the Township Police Department to conduct a background check for violations of the NJ Fish and Game Code
- o Copy of current certificate of insurance confirming general liability insurance with coverage with combined single limits for bodily injury and property damage of at least \$1 million per single occurrence and \$1 million dollars annual aggregate. If certificate is not available then proof of application must be provided.
